508.12 Examiners of Titles

Subd. 1. Examiner and Deputy Examiner

• The judges of the district court shall appoint a competent attorney in each county to be an examiner of titles and legal adviser to the registrar in said county.

Firmly Committed.



The judges of the district court may also appoint attorneys to serve as deputy examiners who shall act in the name of the examiner and under the examiner's supervision and control, and the deputy's acts shall be the acts of the examiners.

The examiner of titles and deputy examiners shall hold office subject to the will and discretion of the district court by whom appointed.

Firmly Committed



Slow and Mistakes Cause:

- 1) Not a priority
- 2) Not enough torrens to develop expertise
- 3) "I want an examiner that knows more about torrens than I do"
- 4) Solution- Mandatory Torrens CLE



Deputies -Four Counties had no Deputies

- Need a Deputy Examiner for:
 - 1) Conflicts
 - 2) Examiner Unavailable
 - 3) Second Opinion

Appointment Process

Many Registrars Have Been Involved:

- 1) Talk directly to judge-Judges take seriously
- 2) Interview & Recommend
- 3) Problem! Few lawyers in county and little real estate experience
- 4) Merit in regional examiners- but like current examiner



Terms

- Good idea- but I like my examiner
- Good idea- I need a new examiner
- Terms that may be renewed- some counties have terms

Examiners

- Most have deputies for conflicts
- Need to keep examiners local
- Fees are a problem
- Once appointed- few leavemany stay on past regular retirement
- Have good relationship with registrar
